Our staff will arrange a public visitation and funeral ceremony. Includes the basic services of the funeral director and staff, transfer of remains from place of death, filing of death certificate, notification to social security, assistance with obituary, arranging Veteran burial and honors, embalming or climate controlled care, other preparation of the body; (including cosmetizing, restorative art, grooming, and casketing); rental casket, visitation, funeral ceremony, basic urn, cremation, cremation container, personalized stationary package, and use of vehicle. **MEMORIAL SERVICE**

Our staff will arrange a memorial service, attend and handle all details. Service in a church or other facility. Administrative fees may be added to the cash advance items.

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF** .....\$ 645

Our fee for the basic services of funeral director and staff includes staff to respond to initial request for services arrangement conference with family or responsible party arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; and coordination with those providing other portions of the funeral.

**EMBALMING** .....\$ 795

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**DIRECT CREMATION** .....\$ 1,295

The charge for a direct cremation includes removal of remains, cremation fee, necessary authorizations, and basic services of the staff. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard boxes.
